The purpose of this handbook is to set guidelines for all member clubs of Pennsylvania USAG. Pennsylvania USAG is a sub-organization of USA Gymnastics (USAG), and is bound by all rules and regulations set forth in the official Women's Program Rules & Policies and Operating Code. As members of USAG Region 7, all Pennsylvania competitive clubs are also bound to follow policies of Region 7 as set forth by the Regional Administrative Committee. USAG Rules and Policies leaves some decisions to be made at the State level and some to be made at the Regional level, in addition to those made at the national level. The information in this Pennsylvania Handbook is designed to inform members of the decisions/formal votes that have been made or taken that are at the discretion of the State Administrative Committee.

Furthermore, as Xcel grows in popularity more petitions are being requested. A petition begins with a request to the State Chair and is followed by videos of the gymnast showing her skills on each event. Please refer to Rules & Policies for the current requirements if a gymnast wishes to change **levels** or **programs** within USAG; i.e. from Xcel to the Developmental Program or from the Developmental Program to Xcel.

#### HOSTING A MEET IN PENNSYLVANIA

- \*For complete information on hosting a meet, please refer to USA Gymnastics Rules and Policies pages 45-69
- \*Key Points: Refer to <u>USA Gymnastics Rules and Policies pages 18, 19</u> for coaches responsibilities and professionalism
- \*Coaches must be dressed in appropriate attire and may not spot if wearing a cast or medical device that limits mobility in any way.
- \*ONLY competitive athletes and coaches in that session may be on the competition floor.
- \*All-Around athletes may petition for .1 on their lowest scoring event for qualification purposes.

#### PLACING A BID TO HOST A STATE COMPETITION

The following are the criteria that the State Committee looks at when accepting bids for the PA State Meets.

When voting on the PA State Meet hosts, any member who is affiliated with a club bidding, must leave the room when the vote is conducted.

**State Level Competitions:** 

- 1. Host site, preferably in an "Outside" facility. (The State Board will give preference to bids using an "Outside" facility.)
- 2. Experience and ability of the host team to host a large meet.
- 3. Facility:
  - A. Size
  - B. Seating
  - C. Rest Rooms
  - D. Parking
- 4. Host team participation in State sponsored activities.
- 5. Equipment:
  - A. Type
  - B. Condition
- 6. Willingness to cooperate with the State Committee.
- 7. Timeliness of bid submission.
- 8. See bid form for details.

#### MEET DIRECTORS' CHECKLIST

- \*Only coaches or club representatives should contact the Meet directors.
- \*Do not have parents contact the Meet director for any reason.

#### PRIOR TO COMPETITION:

- 1. Request a Sanction from USA Gymnastics a MINIMUM of thirty days prior to the meet. Sanction fees for in-person competitions are \$250.00.
- 2. Request judges online at <a href="https://gymjas.com/pa/meetdir.php">https://gymjas.com/pa/meetdir.php</a>. Fee for judge request is \$5.00 per judge/ per day requested (ie/ 8 judges for 2 days = \$80.00). If the request is received less than 30 days prior to the competition, the fee is \$7 per judge/ day. #### **AFTER COMPETITION:**

- 1. Make sure that the Meet Ref and Meet Director have signed and completed the Sanction Report Form and Meet Referee Report Form.
- 2. Make sure the judges have signed the Judges Sign-In Sheet.
- 3. All coaches must sign the Coaches Sign-In Sheets.

\*Within 72 business hours of the conclusion of the event, mail or email the Sanction Report Form, Safe Sport Event Checklist, Meet Referee Report Form, Judges Sign-In Sheet and Coaches Sign-In Sheets to USA Gymnastics.

- \*Failure to submit the completed sanction forms within the stated timeframe may result in and/or be considered a violation of sanction.
- \*Head tax should be sent as soon as the sanction is closed. In accordance with Rules and Policies, sanctions are to be closed 72 hours after the completion of the event.
- \*Head tax is owed to the state and region for **ANY** participants who competed in that sanctioned session.
- \*Further clarification: Gymnasts may **NOT** be included in a sanctioned session if they are not listed on the sanction. If you are having athletes judged just for feedback, they need to be a separate unsanctioned session.
