

**The Pennsylvania USAG committee held a zoom meeting on December 14th.**

**State Chairperson Donna Guenther called the meeting to order.**

**1. Modifications have been made to the PA post season calendar.**

**April 30<sup>th</sup>-May 2<sup>nd</sup>: Xcel States**

**May 7<sup>th</sup>-9<sup>th</sup>: Level 4 States**

**May 7<sup>th</sup>-9<sup>th</sup>: Level 6 States**

**May 14<sup>th</sup>-16<sup>th</sup>: Level 3 States**

**May 14<sup>th</sup>-16<sup>th</sup>: Level 7 States**

**2. A motion was made to postpone level 9 and level 10 states indefinitely due to the covid situation and the uncertainty surrounding it. Gymnasts will be able to qualify to lev 9 and 10 Regionals by scoring a 34.00AA at any USAG sanctioned competition OR by using a score from last season (2019-2020) if the score is a 34.00 or higher (at the SAME level). IES gymnasts may also qualify to Regionals by scoring a 9.0 in the event they are planning to compete. Vote: Unanimous**

**3. A motion was made to postpone level 8 states indefinitely due to the covid situation and the uncertainty surrounding it.**

**Gymnasts will be able to qualify to lev 8 Regionals by scoring a 35.00AA at any USAG sanctioned competition OR gymnasts may**

**use a score from last season (2019-2020) if the score is a 35.00 or higher (at the SAME level). As in the past, there is NO IES qualification to Level 8 Regionals. Vote: Unanimous**

- 4. It was motioned that for the 2020-2021 season there be no team competition at states. The reason for this being with the uncertainty of shutdown and quarantines, we did not want parents, athletes or clubs to feel pressured to have certain gymnasts ready for team competition The vote was unanimous. Passed.**
